- Brief report of current status of the garden
- Background:
 - Began Spring 2020 - UEL thinking about a long term plan for area D, wanting to use green space to make a community garden. Regent College and volunteers from the community formed a society under the BC Societies act.
 - Have liability insurance.
 - Thanking sponsors Gandy's Home Hardware, Hewer Home Hardware, Kerrisdale Lumber, Alison Fong
- Purpose of the garden:

- Provide residents with the opportunity to grow food and flowers, foster connections between people, opportunities for people to learn about food and gardening, model an inclusive community, enhance beauty of neighborhood
- Future plans:
 - Launch event coming soon
 - Communal herb garden - plot set aside for gardeners to share herbs
 - West coast seeds donated seeds for members to use
- Volunteering opportunities:

- Garden phases
